I understand that I can request the Departmental Secretary of the Water Supplies Department at 48/F, Immigration Tower, 7 Gloucester Road Hong Kong for access to and correction of the personal data.

3. any documentary evidence supporting your relationship with the registered consumer; and
4. a photocopy of your HK Identity card/ Passport;
5. for father/mother/brother/sister applying for the refund, document supporting your relationship with the registered consumer and Declaration showing that you are the only person to submit such application.
6. for refund of \$1,000 or above or your relationship with the registered consumer is other than the above, Grant of Probate /Letters of Administration/Confirmation Notice issued by Home Affairs Department is required.
