WSD Circular Letter No. 2/2017 Water Efficiency Requirements for Fittings in Inside Service

To promote water conservation, the Water Supplies Department (WSD) launched the voluntary Water Efficiency Labelling Scheme (WELS) in 2009 to help consumers select water efficient plumbing fixtures and appliances to save water consumption. To further promote water conservation and enhance the penetration rate of water efficient devices, the Water Authority (WA) considers that after over seven years' implementation of WELS on a voluntary basis, it is now at a suitable juncture to commence the first stage of mandating the use of products registered under WELS. We will implement subsequent stage of mandating the use of WELS products later.

Under the first stage of the mandatory use of WELS products, for all proposed plumbing works submitted using the Form WWO 46 for designated part of premises as listed below, the proposed products to be used for showers for bathing¹, water taps² and urinal flushing valves (termed "designated products" herein below) should comply with prescribed water efficiency gradings registered under WELS as detailed in Table A, subject to the exemption as set out in <u>Annex A</u> to this letter:

¹ In accordance with Section 3.5 of the Scheme Document for WELS on showers for bathing, the term "showers for bathing" covers showerheads installed to fixed arms/concealed pipes in the wall or ceiling, showerheads installed to pivotal arms and hand-held showers.

In accordance with Section 3.5 of the Scheme Document for WELS on water taps, the term "water taps" covers mixing or non-mixing type water taps installed at bathroom/toilet washing basins and pantry/kitchen sinks. Water taps equipped with automatic sensing open/close device or automatic closing mechanism are also included. However, water taps installed at bath tub/shower, any system, machinery and devices such as irrigation system, washing machines, water dispensers etc. which serve for bathing/operational use, are excluded.

Designated part of premises

- (a) kitchens of the domestic premises
- (b) bathrooms and toilets of all premises

The WSD has commissioned a consultant to carry out a Business Impact Assessment (BIA) study to identify the potential impacts of the mandatory requirements on the trades and to advise on the possible mitigation measures to facilitate compliance. In particular, the BIA consultant has collected views from different stakeholder groups including suppliers, buyers³, service providers⁴ and testing laboratories. The BIA study concludes that all stakeholders should be able to comply with the mandatory requirements without significant compliance difficulties if all the recommended mitigation measures are fully adopted. In accordance with the results of the BIA study, the WSD has adopted all the recommendations in formulating the mandatory requirements. On the other hand, the WSD has separately consulted other parties, including the Advisory Committee on Water Supplies, the Technical Committee on Plumbing, the Business Liaison Group⁵ (Hotels), the Business Facilitation Advisory Committee (BFAC)⁶ and the Food Business and Related Services Task Force⁷ before finalising the mandatory requirements.

The above requirements will take effect from 1 February 2017 with a one-year grace period, during which the use of designated products that comply with the prescribed water efficiency requirements in Table A is optional. Upon the expiry of such grace period (i.e. starting from 1 February 2018), the use of such designated products shall become fully mandatory.

The group is a formal discussion forum established to further strengthen communication between the hotel trade and the Government on licensing and regulatory matters at the operational level.

Its membership includes representatives from the Chinese General Chamber of Commerce, the Chinese Manufacturers' Association of Hong Kong, the Federation of Hong Kong Industries and the Hong Kong General Chamber of Commerce as co-opted members. Its major duties are to advise and report to the Financial Secretary the development and implementation of programmes and measures to facilitate business.

The Task Force is set up under BFAC to conduct sector-specific or licence-specific regulatory reviews and facilitate food business consultation on regulatory proposals. The BFAC steers the Task Forces and oversees its work progress.

In connection with the above requirements, the "Hong Kong Waterworks Standard Requirements for Plumbing Installation in Buildings" and the Form WWO 46 are revised as set out in <u>Annex B</u> and <u>Annex C</u> to this letter respectively. In particular, the revised Form WWO 46 (version 1/2017) shall be used for all new submissions with effect from 1 February 2017. For those plumbing works with initial submission of the Form WWO 46 (version 6/2012a or 10/2015) made before 1 February 2017, the same version of the form can be used to complete the remaining procedures, provided that the submission has not been subsequently rejected by the WA. For those applications submitted before 1 February 2017, if the applicants choose to join the mandatory use of WELS products wholly or partly, they should use the revised form for such cases.

For a water tap or shower for bathing not complying with the above water efficiency requirements, the WA will accept the alternative of installing inside the water tap or shower for bathing a flow controller registered under WELS and of appropriate water efficiency grade to form a "combined" water saving device that meets the prescribed water efficiency requirements in Table A above. The applicant would be required to submit, together with the Form WWO 46, test reports of flow rate test⁹ of the "combined" water saving device conducted within 5 years before the date of submission to demonstrate compliance with Table A. The above flow rate test and the submission of such reports are optional before 1 February 2019 but shall become mandatory with effect from 1 February 2019.

To promote more choices of water saving devices, the WSD will implement a recognition mechanism in which water saving devices registered in other jurisdictions that comply with the requirements of WELS can be recognised under WELS. Under such mechanism, the applicant can submit a certified true copy of relevant test report of the concerned product used for registration under the concerned jurisdiction to save the need and the associated cost of conducting a fresh test by a laboratory accredited by the Hong Kong Accreditation Service (HKAS) or mutually recognised by HKAS according to the requirements of WELS.

Having reviewed the testing standards and requirements, the WSD considers that water saving devices registered in Australia and New Zealand can be recognised under WELS. The WSD will continue to review those in other jurisdictions and update the coverage of the recognition mechanism via the WSD website in due course.

Criteria for Exemption

For the Form WWO 46 submitted after expiry of the grace period, i.e. 1 February 2018, applicants may apply for exemption from the requirements within the scope of designated part of premises under the following scenarios:

Scenario (A)

All premises with tenders/quotations concerning the installation of showers for bathing, water taps or urinal flushing valves therein invited before 1 February 2017 may be eligible for exemption from the mandatory use of designated products registered under WELS.

To apply for exemption, in the submission of the Form WWO 46, the applicant shall:

- (a) submit documentary proof of such tender/quotation or the existence of such tender/quotation; and
- (b) demonstrate that the specifications stipulated under the said tender/quotation for the use of those designated products could not fulfill the prescribed water efficiency requirements to the WA for verification and approval.

Scenario (B)

For all premises, applications for exemption based on technical issues like inadequate water pressure for the operation of water heater after the installation of designated products will also be considered on a case-by-case basis. To apply for exemption, the applicant shall provide information to fully justify why the mandatory use of designated WELS products cannot be complied with in the submission of the Form WWO 46.

Scenario (C)

For all premises, applications for relaxation of requirements based on reasons other than those under scenarios (A) or (B) will also be considered on a case-by-case basis. The relaxation may be in the form of relaxing the flow rate requirements of certain designated products or exempting certain designated part of premises from the mandatory requirements. To apply for the relaxation, the applicant shall provide detailed information in the submission of the Form WWO 46 to fully justify why the mandatory use of designated WELS products cannot be fully complied with.

For all premises, applications for exemption based on technical issues like inadequate water pressure for the operation of water heater after the installation of designated products will also be considered on a case-by-case basis. To apply for exemption, the applicant shall provide information to fully justify why the mandatory use of designated WELS products cannot be complied with in the submission of the Form WWO 46.

Scenario (C)

For all premises, applications for relaxation of requirements based on reasons other than those under scenarios (A) or (B) will also be considered on a case-by-case basis. The relaxation may be in the form of relaxing the flow rate requirements of certain designated products or exempting certain designated part of premises from the mandatory requirements. To apply for the relaxation, the applicant shall provide detailed information in the submission of the Form WWO 46 to fully justify why the mandatory use of designated WELS products cannot be fully complied with.

- 3. The Form with the Annex shall be mailed/faxed to the Water Authority.
- 4. Different sets of Forms are required for different phases of the plumbing that require water supply at different dates. The consumer #/agent #/applicant of new water supply in Part II and/or the Licensed Plumber/Authorised Person in Part I shall inform the Water Authority in writing whenever there is any change to the 'anticipated date when water supply is required' in Part I of the Form.
- 5. On completion of processing the application, the Licensed Plumber, the Authorised Person and the consumer */agent*/applicant will receive Part III of the Form with a Form Serial No. printed on it. A copy of Parts I and II of the Form will also be returned.
- 6. Reporting completion of part of the Approved Plumbing Works covered by this Form (including water pipe to be concealed) shall be made in Part IV of the Form. Licensed Plumber, and the Authorised Person and consumer #/agent #/applicant as appropriate, should complete Part IV of the Form and submit it together with a copy of Parts I, II and III of the Form to report completion of the Approved Plumbing Works covered by this Form. **Please quote Form Serial No. and ASN on Part IV.**
- 7. All pipes intended to be used for the Approved Plumbing Works covered by this Form are required to be reported in the Annex. For fittings intended to be used for the Approved Plumbing Works covered by this Form, only those fittings listed in WSD's website and showers for bathing need to be reported in the Annex.
- 8. All pipes and fittings including any materials intended to be used for the construction, installation, alteration or removal of the Approved Plumbing Works covered by this Form shall comply with the relevant British Standard listed out in WSD's website and all water taps, showers for bathing and urinal flushing valves intended to be installed shall be registered under WELS and comply with the prescribed water efficiency requirements stipulated in the HKWSR. If the following four categories apply to any pipes, fittings or materials intended to be used, the applicant should specify the relevant category on the Annex and provide the relevant supporting documents:
 - Category A Marked in accordance with the appropriate British Standard and bearing the British Standard Institution Kitemark. The relevant approval certificate should be provided.
 - Category B Accepted by the Water Supply (Water Fittings) Regulations, United Kingdom (formerly known as the Water Byelaws). The relevant approval certificate should be provided.
 - Category C Accepted by the Water Authority in writing. Copies of the relevant WSD approval letters should be provided to facilitate final inspection.
 - Category D Accepted by the WSD in writing for registration under WELS and in compliance with the prescribed water efficiency requirements stipulated in the HKWSR. Copies of the relevant WSD approval letters should be provided to facilitate final inspection.

A directory of pipes and fittings including any materials with currently valid approval by the Water Authority as well

as the registers of products covered by the current WELS can be found in the WSD's website. For pipes and fittings not yet approved by the Water Authority, submission of details and samples of such pipes and fittings including any materials listed in the Annex may be required. For water taps, showers for bathing and urinal flushing valves not yet registered under WELS, submission of details of such fittings listed in the Annex may be required for registration under WELS.

- 9. Licensed Plumber and Authorised Person should always be aware of the anti-corruption laws and avoid to contravene them during their course of works. For details, please refer to the website of Independent Commission Against Corruption at http://www.icac.org.hk/
- 10. For a water tap or shower for bathing not complying with the prescribed water efficiency requirements stipulated in the HKWSR, the Water Authority will accept the alternative of installing inside the water tap or shower for bathing a flow controller registered under WELS and of appropriate water efficiency grade to form a "combined" water saving device that meets the prescribed water efficiency requirements. To select such flow controller for non-mixing type water tap, applicant should refer to the WELS registers in WSD's website to ascertain its nominal flow rate to achieve the prescribed water efficiency requirements. Details of the WELS compliant flow controller to be installed to form a combined water saving device shall also be included in the Annex.
