WSD Circular Letter No. 4/2018 Technical Requirements for Plumbing Works in Buildings and **Guide to Application for Water Supply**

This Circular Letter is to promulgate the "Technical Requirements for Plumbing Works in Buildings" (Technical Requirements) and "Guide to Application for Water Supply" (Guidebook). The Technical Requirements and the Guidebook serve mainly a consolidation and update of the technical and submission requirements set out currently in the Hong Kong Waterworks Standard Requirements for Plumbing Installation in Buildings, the Handbook on Plumbing Installation as well as the Circular Letters as listed in the **Appendix**. The WSD has consulted the Technical Committee on Plumbing on the Technical Requirements and the Guidebook.
