Circular Letter No. 6/2020 Updated Version of "Technical Requirements for Plumbing Works in Buildings" and "Guide to Application for Water Supply"

The October 2019 version of the "Technical Requirements for Plumbing Works in Buildings" (Technical Requirements) and "Guide to Application for Water Supply" (Guidebook) were published in October 2019. Subsequently, a series of Circular Letters have been issued to stipulate the latest technical requirements and submission guidelines.
