# WSD Circular Letter No. 4/2022

# New Requirements on Inspection of carrying out Non-Destructive Tests at Solder Joints

To ensure quality of fresh water in inside service, the Licensed Plumbers (LPs) are responsible to ensure the plumbing works and the corresponding testing in full compliance with the requirements in the Waterworks Ordinance, the Waterworks Regulations, the WSD Circular Letters, as well as the publications "Technical Requirement for Plumbing Works in Buildings" and "Guide to Application for Water Supply".

2. Currently, during inspection of the inside service, non-destructive tests of lead content at solder joint samples selected by the Water Authority (WA) shall be carried out according to the requirements set out in Section 4.3.4 and Appendix 12 of "Guide to Application of Water Supply".

3. WSD has the responsibility to remind the plumbing trade that the *procedures stated in the instruction manual by the corresponding manufacturer should be strictly followed* when conducting the said non-destructive tests. Special attention should be paid to the specified sequence of each step and time limitation on





the overall testing process, techniques of activation and handling of the testers, provision of test assurance checking, clarity of the results, etc.

#### **Additional Requirements**

4. To ensure the procedures stated in the manufacturer's instruction manual are strictly followed to conduct the tests effectively, the responsible LP or his/her representative should give a briefing to the WSD staff on the procedures he/she would follow and shall be agreed with the WSD staff who are going to witness the test prior to conducting the non-destructive tests at solder joint. The WA may request the LP or his/her representative to carry out further tests if the tests are considered not carried out strictly according to the manufacturer's instruction manual.

## **Effective Date**

5. The above new requirements will take immediate effect.
