## WSD Circular Letter No. 2/2023

# Enhanced Time Frame for Issuing Reminders and Cancellation in Processing Applications for Water Supplies (AWS)

To ensure efficient processing of AWS, the Water Supplies Department (WSD) has established a mechanism on reminding applicants to respond to the WSD's comments on their plumbing proposals.

### **Enhanced Time Frame**

2. After implementing the current time frame for issuing reminders and cancellations of AWS for two years, we have reviewed the past statistical data in processing AWS and considered that there is room for enhancement. By doing so, and if the applicants can respond to the WSD's comments adequately and timely, the number of subsequent WWO 1082 and hence the time allowed for follow-up actions should be reduced progressively. As a result, enhanced time frames are proposed for issuing reminders and cancellation, which will be issued to applicants before the deadline for response to WWO 1082 to remind them of the outstanding responses and the possible cancellation. The application will be cancelled if there is no response after the expiry of time allowed for response to WWO 1082. The proposed enhancements are summarized as below:
