## WSD Circular Letter No. 11/2025 Drinking Water Dispensers Installed in Inside Service

To promote wider use of registered drinking water dispensers under the Voluntary Labelling Scheme for Drinking Devices – Drinking Water Dispensers and Filters (the DWDF Scheme)<sup>1</sup>, this Circular Letter promulgates the administrative measure for mandating the use of registered drinking water dispensers<sup>2</sup> for Applications for Water Supply (AWS).

#### **New Requirement on Installation of Drinking Water Dispensers**

2. Under the new requirement, drinking water dispenser to be used in inside service shall be included as a reporting item(s) by indicating the registration number under the DWDF Scheme in the enclosed new Form WWO 1149B prior to the commencement of the plumbing works (i.e. when submitting Part I & II of Form WWO 46). For avoidance of doubt, the current requirement of backflow prevention device for installation of drinking water dispensers and other relevant requirements mentioned in the latest version Technical Requirements for Plumbing Works in Buildings (currently January 2025) is required to be met.

<sup>&</sup>lt;sup>2</sup> In accordance with Section 3.6 and 4 of the DWDF Scheme document, drinking water dispensers means a factory-made assembly which includes cold and/or hot water dispensers and drinking fountains equipped with a nozzle to provide a stream of water for direct human consumption. Any device which provides drinking water as a subsidiary function is not included in the DWDF Scheme (e.g., refrigerator with water dispenser function).

#### **Effective Date**

3. The effective date of reporting the abovementioned drinking water dispensers shall be **2 October 2026**.
