GREEN PROCUREMENT

1. General

This specification covers the green specifications for a list of 183 items of products commonly purchased by bureaux and departments as recommended by Environmental Protection Department (EPD) in 2021 (revised in January 2025). In line with the Government's commitment to promote green procurement, Bureaux and departments are encouraged to adopt the respective green specifications whenever they purchase items on the list as far as possible. Details of the list of products and services and the recommended green specifications are stipulated in the Environment Bureau Circular Memorandum (EBCM) No. 1/2021 on "Green Procurement in the Government" and its subsequent amendments.

In addition to the above, products and services that can reduce carbon footprint during their manufacturing and operational processes are desirable and shall be adopted for use as far as possible if the functional requirements can be complied. Examples of such products may include natural organic products, high energy efficient equipment, B5 diesel oil, etc.

2. Green Procurement Requirements

The recommended green specifications of the prevailing 183 items as well as their verification methods can be downloaded from the following website at https://www.eeb.gov.hk/en/susdev/green_procure/green_spec.html. The list of items with green specifications may be reviewed and expanded by EPD from time to time.

According to EBCM No. 1/2021, if the products and services that are planned to be purchased are on EPD's green product/service list, the recommended green specifications for these items shall be adopted and included in the tender specifications.

The recommended green specifications in EPD's green product/service list are divided into mandatory requirements and desirable requirements. When there are three or more models meeting the green specifications for each product/service, it is considered that there is an adequate supply of that product/service in the market. In this connection, the product/service shall be specified as "mandatory" green requirements in the tender specifications. However, for green specifications with uncertain market availability, it shall be specified as "desirable" green requirements.

The following specification is prepared with reference to the recommended green specifications promulgated by EPD.

3. Product List with Green Specifications

With reference to the recommended green specifications promulgated by EPD, the design and construction of the following 27 products (out of the 183 items) to be purchased under the M&E contracts shall comply with the green specifications:
