Voluntary GA Product Shop Scheme

General Knowledge for GA Product Shop Salespersons



Eligibility for Registration as a GA Product Shop

- 1) To display the **GA Product Shop Label** affixed with a validity period till end of each year, at a prominent location of the shop for easy identification by the public;
- To sell GA plumbing products of not less than a particular number of models of GA products (in term of number of GA reference) in at least one of the respective categories within the shop;

The **GA Product Shop Label** will be issued according to the category/categories that the shop has met the registration requirements as illustrated below:









- To display the GA Labels for plumbing products on sale that have joined the Voluntary GA Labelling Scheme, together with publicity materials, including posters, leaflets, shelf wobblers and leaflet dispensers, for the Voluntary GA Labeling Scheme in the shop;
- 4) To mark/print the GA Reference Numbers of the GA plumbing products on official sale receipts issued to the customers; and
- 5) To apply for renewal of registration annually.



Point to Note for GA Product Shop(1)

To display the **GA Product Shop Label** affixed with a validity period till end of each year, at a prominent location of the shop for easy identification by the public









Point to Note for GA Product Shop(2)

To sell GA plumbing products of not less than a particular number of models of GA products in at least one of the following categories within the shop

Categories of GA Shop	Required No. of Models of GA Products (in term of number of GA reference)	
Valves	min. <u>5 models</u> of GA product	
Pipes and Pipe Fittings	min. <u>5 models</u> of GA product	
Taps and Mixers	min. <u>10 models</u> of GA product	
Soldering/Brazing Materials	<u>Lead-free</u> solder only and all the solder/brazing materials on sale are GA products

Publicity materials, including posters, leaflets, shelf wobblers and leaflet dispensers, for the "Voluntary GA Labeling Scheme" in the shop




