- Description of visuals** : The opening shot shows the living room of an apartment  
A close-up shot shows the wife just finished making a cup of coffee with latte art  
The scene then pulls wide showing wife serving coffee to her husband  
Her husband is working with a computer  
Wife says:
- Wife** : Tastes good?
- Description of visuals** : The scene switches to a close-up shot showing the husband taking a closer look at the coffee  
He responds:
- Husband** : Ah!
- Description of visuals** : The scene then changes to another shot showing the wife  
She is eager to know her husband's comments  
Wife says:
- Wife** : Let me know your views!
- Description of visuals** : At this moment, a close-up shot shows the animated character of the Water Supplies Department's mascot  
Water Save Dave jumps out from the glass pitcher which is full of water and is placed on the table  
Water Save Dave speaks to the couple:
- Water Save Dave** : The Water Supplies Department wants to hear your views too!
- Description of visuals** : The couple are amazed to see Water Save Dave  
The text "Public Consultation on Proposed Amendments to Waterworks Ordinance" appears on the screen  
Water Save Dave continues:
- Water Save Dave** : The Government is seeking public views on proposed amendments to the Waterworks Ordinance
- Description of visuals** : The scene changes to an indoor renovation site  
A medium shot shows Water Save Dave slides down the water pipes  
mounted on the wall of the building corridor  
Water Save Dave speaks in front of the camera:

| <b>Water Save Dave</b>        | : They include strengthening control of plumbing materials and works  |
| <b>Description of visuals</b> | : As Water Save Dave is speaking, he sees a plumber using a spanner to fix part of the water pipe mounted on the wall of the building corridor<br>They look at each other<br>The plumber nods and smiles in returns<br>Water Save Dave continues:   |
| <b>Water Save Dave</b>        | : to further safeguard drinking water safety  |
| <b>Description of visuals</b> | : As Water Save Dave is speaking, the scene changes to a split screen showing four types of plumbing fixtures and water-consuming devices, namely, shower head, water saving device installed at a water tap, faucet and washing machine<br>Then Water Save Dave presents the “Water Efficiency Label” in front of the camera.<br>Water Save Dave continues by saying:  |
| <b>Water Save Dave</b>        | : as well as enabling the introduction of a mandatory water efficiency labelling scheme to help consumers choose water-efficient products   |
| <b>Description of visuals</b> | : The scene switches to a private housing estate<br>Water Save Dave flies into the housing estate and then landed on the ground of the outdoor common area of a housing estate<br>Then the camera shows a close-up of Water Save Dave immediately penetrates into animation setting of the ground and points to a leaking underground private communal water main with fresh water running off<br>Water Save Dave faces the camera and says:  |
| <b>Water Save Dave</b>        | : Ways to prevent fresh water loss in private communal water mains will also be explored  |
| <b>Description of visuals</b> | : The end shot shows the living room of the couple<br>Water Save Dave invites the couple to give their comments and views on the Proposed Amendments to Waterworks Ordinance<br>The screen also shows the text “Public Consultation on Proposed Amendments to Waterworks Ordinance”, “Public consultation ends on February 3, 2021”, the website <a href="http://www.wsd.gov.hk">www.wsd.gov.hk</a> and the logos of the Development Bureau and Water Supplies Department<br>Water Save Dave continues: |
